Responsibilities:

- Provide direct nursing care in accordance with established policies, procedures and protocols of the department.
- Provide nursing care by assessing the patient pre-infusion obtaining brief history and review of medications and any other changes/concerns since last visit.
- Obtain and record all vitals, including weight, documenting time, method used.
- Establish peripheral intravenous (IV) access documenting time started, location and method used.
- Ability to access and care flush, if needed
- Confirming medication dose needed for infusion and mixing to manufacturer's instructions.
- Verify medication has no impurity before adding to mixture
- Clear understanding of use of infusion pump and other machines needed to perform duties
- Monitoring patients during infusion process, documenting any additional care or treatment given. Alerting provider if needed.
- Keeping all rooms cleaned and stocked with any needed supplies
- Documenting healthcare information into EMR
- Confirming orders are complete and up-to-date. Starting new orders for provider review and signature when appropriate
- Assisting with pre-authorization process
- Knowledge of emergency procedures in event of reaction to medication

Required Qualifications/Special Training

- Current WA State RN license with no restrictions
- Healthcare workers BLS
- Experience with peripheral intravenous (IV), port access
- Ability to administer injections, EKG's
- Experience with EMR
- Critical thinking and decision making skills
- Ability to demonstrate the knowledge and skills necessary to provide care appropriate to the age of the patients served.
