### **Education Background**

- Medical Assistant-Certified (MA-C) credential from the Washington State Department of Health.

- Must be a highly motivated CMA with a willingness to learn the roles of Pulmonary Function Testing and Home Sleep Tests.

### **Work Experience**

- Previous medical clinic office experience preferred
- At least 1-year experience as a Certified Medical Assistant-Certified or at least completed externship and graduated from an accrediting MA school.
- 1-year experience in a Pulmonary Care Center preferred, not required
- Experience with pulmonary function testing preferred, not required

- Willingness to learn and perform home sleep study set ups
- Must be medical device and technologically proficient.
