#### **Duties/Responsibilities:**

The medical assistant will help the Provider in the assessment, diagnostic testing, examination, education and treatment of patients. Collaborates with other professional disciplines and provides efficient patient care and the achievement of desired patient outcomes.

#### Summary of essential job functions:

- Perform general patient care by following established standards and procedures
- Greet and prepare patients for the healthcare provider
- Obtain and record vital signs including, but not limited to, blood pressure, temperature, pulse, respiration, height, weight, drug allergies, and current medications
- May be required to draw and collect blood samples from patients and prepare specimens for laboratory analysis
- Administer ordered medications and/or vaccines via oral, injection, topically, ophthalmic, or inhalant administration
- Perform routine tests, including but not limited to, EKGs
- Schedule patients for diagnostic testing and follow up to be certain of completion of testing
- Communicate with patients regarding test results and plan of care by phone or mail as directed by provider

- Prepare, clean and sterilize instruments and maintain equipment; keep patient exam rooms stocked, clean and orderly; dispose of contaminated items according to protocol
- Document patient plans of care, tests and examination results in the medical record as directed by the provider
- Escalate non-routine issues, questions and or concerns to the practice manager or providers
- Make sure that safety checklists/quality controls are completed as required
- Provide for patient safety and protection of patient privacy rights
- Light office work
- Other duties as assigned

- High school diploma or GED required; completion of an accredited medical assistance certification program is preferred

- Ability to communicate clearly with patients and other external and internal parties in a courteous and friendly manner
